

2019 EUACI Call for CSO Proposals – Ukrainian Registered CSOs

Stage One – Concept Note: Questions and Answers

This document lists the questions sent to the EUACI regarding the concept note submission (2019 EUACI Call for CSO Proposals – Ukrainian Registered CSOs announced on April 17, 2019) and provides answers to the questions received.

Question 1. What is the deadline for the project concept submission? In what language should be submitted a concept note?

May 15, 2019 17:00 Kyiv time is the deadline for the concept note submission. Please submit a concept note written in English.

Question 2. Do you have a template for the concept note? In what format (electronic or paper) should the concept note be submitted?

We do not have a specific template/form. The concept note (electronic format) should be submitted within the above mentioned deadline to the e-mail: natvas@ukraine-aci.com, Nataliya Vasyukhnik, Civil Society Specialist, e-mail subject: Response to 2019 EUACI Call for CSO Proposals.

Please be informed that concept note should comply with the following criteria:

- up to 4 pages (A4 size) of Arial 10 characters with 2 cm margins, single line spacing;
- contains problem identification, the objective, expected outcomes and specific outputs that will be delivered, as well as target audience, beneficiaries, workplan and a budget based on estimations;
- fully discloses previous experience in the field of implementation the anti-corruption projects and any support from other donors/partners during the previous five years.

Question 3. Can one organization submit several concept notes?

We will consider only one concept note from one organization.

Question 4. Do you issue grants to individuals? Do you issue grants to international organizations? Can Ukrainian regional or local civil society organizations apply?

Only legal entities, non-profit-making, national, regional and local civil society organizations established, registered in Ukraine are eligible for the EUACI grants.



Question 5. Can organizations that do not have anti-corruption objectives included in their statutory goals apply for the EUACI grants? Are organizations required to have previous experience in implementing anti-corruption projects

Organizations that do not have anti-corruption objectives included in their statutory goals are eligible for the EUACI grants. We only require them to have previous experience in the field of implementation of the anti-corruption projects.

Question 6. Are young civil society organizations that previously did not receive any grants from donors eligible to apply?

Yes, they are eligible to apply but they still need to prove that they have expertise and previous experience in the field of the submitted project concept.

Question 7. Do you have allowable & unallowable costs regulations, budget limitations? Do you require co-funding?

There are no budget limitations, all costs are allowable if they are necessary, reasonable and allocable. We do not require co-funding.

Question 8. Do you require any agreements/memorandum between organizations and state institutions to be signed for the first stage, concept note submission stage?

For the first stage, applicants are not required to have any agreements/memorandum signed.

Question 9. Do you require partners, coalitions for the project implementation?

We do not require partners, coalitions for the project implementations but if there are partners, please indicate them in the concept note.

Question 10. What kind of activities, project themes will EUACI support with this grant call?

The objective of this call for proposal is to support CSOs activities focused on:

- application and promotion of accountability and transparency mechanisms on national, regional and local level;
- oversight over and monitoring of anti-corruption reforms delivery on national, regional and local level;
- support to dialogue on anti-corruption reforms implementation between civil society, government, business and other stakeholders;
- anti-corruption advocacy and raising awareness campaign;
- civic education for youth and youth involvement in finding innovative ways to address corruption.





Question 11. Will you support a project focused on implementing activities only in one region?

A project can be implemented in one region. We support implementation of the anti-corruption mechanisms on national, regional and local level.

Question 12. Do you provide pre-evaluation services to the applicants? Can we send you either our project summary or concept note before the deadline and get your feedback on it?

The EUACI ensures fair competition. We can't provide any pre-evaluation services to the applicants; we can't give any feedback on the project summary or concept note submitted before the deadline.
